# Pierce County Terminal Fender Replacement Project Authorization

### **ACTION REQUESTED**

Request project authorization from the NWSA Managing Members in the amount of \$4,658,000 for a total authorized amount of \$4,945,000 for the Pierce County Terminal Fender Replacement Project, Master Identification No. 201145.01.



#### Background

- Existing fender system was designed and installed at Pierce County Terminal (PCT) in 2004.
- The existing fender system was designed based on standard vessels that were calling at that time, typically between 6,000 and 6,500 TEU.
- The new fender units that are proposed to be installed are designed to support larger vessels. Currently, vessels calling at PCT range from 6,000 to 12,000 TEU.



## Project Description and Details

The Scope of Work will include:

- Removal of 34 existing fender units
- Installation of 39 new fender units
- Repair areas of spalling concrete on pile caps
- Procure two (2) additional fender units to have on hand as spares

Work will be sequenced to avoid disruptions in both vessel and yard operations.

#### Source of Funds

- The estimated cost and budget of this project is \$4,945,000.
- The current Capital Investment Plan (CIP) allocates \$4,945,000 for this project.
- This project meets the requirements for use of Harbor Maintenance Tax funds.
- This work and associated budget is consistent with the NWSA valuation.
- Design work completed since 2022 was previously authorized and has been completed.

# Alternatives Considered and Their Implications

- No Action Alternative: Keep replacing fender units when they are damaged. This could result in restrictions to vessel size at PCT and result in berthing delays while repairs are made.
- Recommended Action: Replace the fenders with new fender units that will reduce ongoing repair needs and allow larger vessels to berth without restrictions at PCT.
