SPECIAL MEETING

JUNE 25, 2024 – 9:30 AM Public Session Start Fabulich Center, Room #104: 3600 Port of Tacoma Road, Fife

The Port of Tacoma Commission met for a Special Meeting on June 25, 2024 at the Fabulich Center, 3600 Port of Tacoma Road, Fife, WA. Commissioners John McCarthy & Dick Marzano attended in person, and Commissioner Don Meyer attended remotely via phone. Commissioners Kristin Ang & Deanna Keller were excused due to Commission international travel. A quorum was met.

1. CALL TO ORDER and FLAG SALUTE:

Commissioner John McCarthy, Port of Tacoma Commission Vice President, called the meeting to order at **9:36 a.m.** The public meeting began with the Pledge of Allegiance. Commissioner McCarthy acknowledged that we are situated on the traditional homelands of the Puyallup Tribe and committed to uplifting the voices, experiences, and histories of the Indigenous people of this land.

- 2. APPROVAL OF AGENDA: The agenda was adopted as presented without objection.

4. COMMISSION ACTIONS:

A. Terminal Security Officer Collective Bargaining Agreement Approval

Michael Dehner (Senior Manager—Labor & Employee Relations) with the Port of Tacoma presented. The Collective Bargaining Agreement (CBA) for Terminal Security Officers includes 13 Regular Officers, including two Lead Officers and five Relief Officers. The previous CBA expired on October 31, 2023 and negotiations continued into 2024. The economic terms for the new CBA were reviewed.

MOTION: Authorize the Executive Director or his delegate to enter into a five-year collective bargaining agreement (CBA) with the ILWU Local 22 Terminal Security Officers (TSOs) for the period of November 1, 2023 through October 31, 2028.

Motion was made by Commissioner Marzano and seconded by Commissioner Meyer. Discussion ensued.
