## Background




- The Federal Highways Administration ordered Fishing Wars Memorial Bridge to close on October 20, 2023.
- Staff procured data to assess the traffic impacts in the Tideflats using vehicle speed as a proxy for congestion for one month before and after the bridge closure.
- Monitoring the bridge replacement and advocating for projects to alleviate congestion affecting the Tideflats area support implementation of the Port's Strategic Plan.

## Bridge Closure – Before and After Study




- Greatest average reduction in vehicle speed (red and orange) is during the PM Peak on:
  - SR 509 (Southbound)
  - Port of Tacoma Rd
  - I-5 (Southbound)
- Moderate reduction (yellow) in average vehicle speed on Lincoln Ave (Westbound) during the PM Peak.
- Other studied corridors showed no change in average vehicle speeds (green).
- Data is from the company Inrix and is based on cell phone, truck fleet and similar information. The data was collected Tuesday through Thursday.









  - 3. As the City of Tacoma advances design for the new Fishing Wars Memorial bridge, we will engage with them about Milwaukee Way and SR 99 to explore options.
