

# AUDIT COMMITTEE MINUTES SEPTEMBER 30, 2021

# 3. APPROVE THE SELECTION OF INDEPENDENT AUDITORS

It was moved and seconded (Marzano/Keller) to approve the selection of independent auditors Moss Adams LLP to provide financial audit services to the Port of Tacoma. The contract for services will be for five-years with an option to extend for two additional years. The contract will be presented to the Port of Tacoma Commission for authorization.

### Discussion:

- State law and bond covenants require audited financial statements annually.
- The current independent auditor contract ends after the audit for calendar year 2021.
- A Request for Proposal (RFP) was published in June 2021. Staff described the RFP evaluation team and the evaluation criteria.
- Two firms responded and Moss Adams LLP was selected. The anticipated fees for the five-year period of the contract are not to exceed \$579,500. The anticipated fees for the two-year option period are \$271,700 combined.
- Moss Adams LLP is a local firm, staff identified some of the clients they serve, including the Port of Seattle.
- The fee structure is comparable to what the Port has paid in the past.
- Commissioner Keller commented the difficulty in changing firms but believe the process was objective. Executive Director, Eric Johnson, supports the selection and also commented the process was solid.
