10:00 A.M.: EXECUTIVE SESSION

1. CALL TO ORDER:

Commissioner Meyer called the Commission Meeting to order at 10:00 a.m. and then recessed into Executive Session for approximately two hours and twenty minutes.

2. RECESS INTO EXECUTIVE SESSION:

- A. One (1) Collective Bargaining Item: RCW 42.30.140
- B. Two (2) Litigation/Potential Litigation Items: RCW42.30.110(1)(i)

At 11:56 a.m. Commissioner Meyer announced the public meeting start time would be delayed approximately 15 minutes.

No decisions were made and no votes were taken.

12:00 NOON: COMMISSION MEETING

1. RETURN TO ORDER:

Commissioner Meyer reconvened the Commission Meeting at approximately 12:20 p.m. and a flag salute was performed.

2. CONSENT AGENDA:

- A. Minutes of February 22, 2018 as amended, March 13, 2018 and March 15, 2018
- B. Check/Wire Certification: Approve the payment of checks 217828 through 218347 and wire transfers in the total amount of \$10,026,935.91 during the period of March 3, 2018 through April 6, 2018.
- C. Parcel 77 Auto Terminal Boundary Line Adjustment 3400 Taylor Way, Tacoma, Washington
- D. Parcel 95 Boundary Line Adjustment 1514 Taylor Way, Tacoma, Washington

Motion was made by Commissioner Petrich, seconded by Commissioner Johnson:

"Approve the Consent Agenda."

VOTE: MOTION CARRIED 5-0

3. PUBLIC COMMENT: None.

4. ACTION AGENDA:

A. Parcel 103 Steam Plant Property

Motion was made by Commissioner Petrich, seconded by Commissioner Marzano:

"Authorize changing the project scope for the Parcel 103 Steam Plant Property Cleanup, Master Identification Nos. 101243.01 and 101243.02."

Discussion Included:

 The Port acquired the Steam Plant property (1171 Taylor Way) from Tacoma Public Utilities (TPU) in 2007. The Purchase and Sale Agreement provides indemnity from TPU for environmental liability, including investigation and cleanup costs stemming from releases of hazardous wastes during Steam Plant operations.

- 2. The Port conducted an initial investigation to determine the nature and extent of contamination associated with historical operations and submitted an open-ended claim for costs totaling \$676,000 in 2012. TPU and the Port disagree over what/who is responsible for the contamination.
- 3. The site does not pose an ongoing or significant threat to human health and the environment. Staff recommends monitoring the site as it returns to its natural state, and collecting supporting data in anticipation of future Ecology review.
- 4. No development or regulatory drivers exist to pursue site cleanup at this time. Discussion took place regarding the timing of claim submission.
- 5. The recently updated claim brings reimbursable indemnity related costs to \$938,120.
- 6. The proposed project scope is resolution of the claim against TPU and to negotiate a cost-sharing agreement for future cleanup.

B. Surplus Storeroom Inventory

Motion was made by Commissioner Marzano, seconded by Commissioner McCarthy:

"Declare storeroom inventory parts associated with cranes formerly owned by APMT surplus, and authorize the CEO to dispose of the items in the most effective and efficient manner." <u>Discussion Included</u>:

- 1. Tenant, SSA, is taking over the responsibility of performing maintenance on the underground power supply at its terminal location. There is no need for the Port to keep an inventory of parts to perform this work.
- 2. Parts are not used on any other cranes in either the North or South harbors.

VOTE: MOTION CARRIED 5-0

C. Avenue 55 Lease - Second Reading

Motion was made by Commissioner Petrich, seconded by Commissioner Johnson:

"Authorize the CEO or his designee to enter into a 50-year lease with a 25-year extension option with Avenue 55, LLC for the premises located at 3402 Lincoln Avenue, Tacoma, Washington." Discussion Included:

- 1. The parcel was purchased in 2007 and was previously used as a log yard. Since being used as a log yard the property has remained vacant for the last seven years.
- 2. Avenue 55 is starting construction on a three-building industrial development that will include 423,940 square feet of new warehouse space. This lease will support that development by allowing maximum warehouse development and possible rail service.
- 3. Terms of the lease were discussed, as were lease benefits to the Port.
- 4. Language regarding Leadership in Energy and Environmental Design (LEED) certification was added to the lease to require that any new industrial buildings over 50,000 square feet constructed on the property will be completed to 90 percent basic LEED Certification as evidenced by a draft LEED Project Score card completed by a LEED accredited professional.
- 5. Commissioner Meyer wants the Port of Tacoma to be leaders is requiring these standards and is appreciative of the efforts of both staff and Avenue 55.
- 6. Commissioner Petrich voiced concerns regarding placing a cap on the annual CPI at 3 percent on a 50-year lease. Rents reset to market at 15-year intervals.

6. STAKEHOLDER UPDATE/GENERAL BUSINESS:

A. Sound Transit Tacoma Dome Link Extension Update

Discussion Included:

- 1. Sound Transit's Curvie Hawkins, Project Development Director and Austin Neilson, Government & Community Relations Officer South Corridor, provided a presentation on the Tacoma Dome Link Extension to the Sound Transit 3 (ST3) Plan.
- 2. The project will connect the Federal Way Transit Center to the Tacoma Dome. The projected start of service date is in 2030.
- 3. Sound Transit is seeking early community engagement. Early scoping continues to May 3, 2018.
- 4. Commissioner Johnson's concerns include adequacy of parking and the logistics of placing a commuter garage in Fife at 54th Street as shown in Sound Transits representative renderings. Strategies for parking management will be looked at by the Sound Transit Board. Certain Sound Transit 2 projects are coming online to specifically address surface parking and accessibly improvements around Tacoma Dome Station.
- 5. Commissioner McCarthy stressed the priority of the project should be getting commuters to and from work as opposed to ridership for recreational purposes.
- 6. Commissioner Meyer expressed concerns of cost adjustments of the project over time.

B. Review of Brokerage Fee and Policy Discussion

Discussion Included:

- 1. Real estate commission payments are addressed in the Master Policy Resolution 2018-01-PT and staff provided a summary.
- 2. Using Pierce County market information gathered from the Commercial Brokers Association, commission fees range from 4 percent to 8 percent. The average commission fee is 5 percent. No tiered commission rates were identified.
- 3. The Port of Tacoma's policy is similar to policies found in other Western Washington ports and competitive with local commission rates.
- 4. Using a broker to list Port properties is not typical, but is useful in unique situations.

C. Centennial Celebration Update

Discussion Included:

- 1. The Port's centennial celebration goals are to celebrate, educate, plan for and look to the future and leave a legacy.
- 2. The Port of Tacoma's centennial anniversary date is November 5, 2018. The Port will begin celebration activities in July which will run through early November.
- 3. An overview was provided of the major events planned. A centennial retiree party, Maritime Fest sponsorship and displays, boat tours, community outreach and an annual event with the Tacoma Historical Society are some examples.
- 4. The Port is exploring options on a possible sculpture or art installation with Metro Parks and the City of Tacoma as a legacy project.

D. Q1 Review: CEO Goals and Expectations

The Q1 review of CEO goals and expectations will be taken up at the May 17, 2018 meeting.

E. CEO Announcements, Events and Recognitions

- 1. The Port of Tacoma received a Corporate/Civic Partner Award last week at the Emergency Food Network's Recognition Breakfast. CEO Wolfe acknowledged Port volunteers who repack emergency food monthly. The Port volunteers repacked more than 66,000 pounds of food.
- 2. Since January an estimated 300 members of the public have taken a tour of the Port of Tacoma through the Port's bus tour program.
- 3. The Port will be presenting a series of nature walks as it celebrates Earth Day. Port biologist, Jenn Stebbings, will lead citizens behind the fence at Place of Circling Waters, a 30-acre remediated habitat site.

7. COMMISSIONER COMMENT:

<u>Commissioner Marzano</u>: Thanked port staff for their work in the community. Provided an update on Puget Sound Gateway discussions taking place on MOU adjustments related to completion of SR-509/167.

<u>Commissioner Johnson</u>: RSM completed its independent financial audit for 2017 and the Port of Tacoma received another clean audit.

<u>Commissioner Meyer</u>: Attended the Tacoma Propeller Club's Lelli Memorial Scholarship Program event. The Port of Tacoma was one of the scholarship sponsors. In the last 24 years the Tacoma Propeller Club has awarded over \$170,000 in cash and merchandise.

8. ADJOURNMENT:

There being no further business, President Meyer adjourned the meeting at 1:30 p.m.





Project Overview

The Tacoma Dome Link Extension will connect Pierce and South King County residents to the regional light rail network, including direct access to SeaTac Airport and downtown Seattle, with stations at Tacoma Dome, East Tacoma, Fife and South Federal Way. The Tacoma Dome station will serve as a multi-modal transit hub, with transfer options to and from Sounder service, Tacoma Link, and Pierce Transit and Sound Transit buses.



Benefits

- 9.7 new miles of light rail service connecting Pierce and South King County to the regional network.
- 4 new light rail stations, from the Federal Way Transit Center station (2024) to Tacoma Dome station.
- Parking garages at the South Federal Way and Fife stations; each with approximately 500 stalls.
- Average projected daily riders by 2040: 27,000 – 37,000.
- Open for service in 2030.
