

REGULAR MEETING

The Port of Tacoma Commission met for a regular meeting on **November 21, 2023** at the Fabulich Center, 3600 Port of Tacoma Road, Fife, WA.

CALL TO ORDER | EXECUTIVE SESSION:

Commissioner Deanna Keller, Port of Tacoma President, called the meeting to order at **10:00 a.m.**Commissioners John McCarthy, Dick Marzano and Don Meyer were present, and a quorum was met. The Commission recessed into a closed **Executive Session** until **12:00 p.m.** to discuss:

1. RETURN TO ORDER:

Commissioner Keller returned the meeting to order at 12:01 p.m. and stated they were in a closed Executive Session from 10:00 a.m. until 11:54 a.m. Commissioners Deanna Keller, Kristin Ang, John McCarthy, Dick Marzano, and Don Meyer were present at the public meeting. The public session began with the Pledge of Allegiance. Commissioner Keller acknowledged that we are situated on the traditional homelands of the Puyallup Tribe and committed to uplifting the voices, experiences, and histories of the Indigenous people of this land.

3. EXECUTIVE DIRECTOR'S REPORT – Eric Johnson

- The first advisory committee meeting for the new Maritime Skills Center in partnership with Tacoma Public Schools occurred earlier in the month. A public meeting will be held next week (11/29/23) at the Foss Waterway Seaport.
- A Joint Study Session with the Tacoma City Council will be held next Tuesday (11/28/23) on decarbonization at City's Municipal building. An update on the Fishing Wars Memorial Bridge closure will be given by the City of Tacoma staff, as well.
- The Washington Public Ports Association (WPPA) 2023 Annual Meeting will be held December 6, 7, and 8 in Vancouver, WA. He encouraged the Commission to attend.

6. COMMISSION ACTIONS:

A. Blair Waterway – Project Authorization & Design Agreement Approval

Tony Warfield (Sr. Project Manager—Environmental & Planning) with the Port of Tacoma presented on the need for deepening the Blair Waterway navigation channel in Tacoma. Container ships are getting much larger and in order to remain competitive with international container shipping businesses, ports much be able to handle the larger ships. A feasibility study with and recommendations by the US Army Corps of Engineers was received, and now ready for the final design phase.

MOTION: "Authorize the Executive Director to enter into the Tacoma Harbor Navigation Improvement Design Agreement with the US Army Corps of Engineers and project authorization in the amount of \$5,615,000 for a total authorized amount of \$5,615,000, for work associated with the Blair Waterway Navigation Channel Deepening Design."

Norm Gilbert (Engineering Project Manager II) with the Port of Tacoma presented and asked for project approval to upgrade fifteen rail switches identified by the Maintenance Track Crew. If deemed unusable, these switches could stop cargo movement.

Gloria Fletcher (Sr. Manager—Real Estate) presented in person and Debbie Shepack (Real Estate Director) presented virtually. The property considered for purchase is adjacent to Parcel #94, which is currently being considered as the site for the Port's Maritime Center. This would enhance access and be included int eh master planning, resulting in less overall development costs for the Maritime Center.

Port of Tacoma 2024 Budget

Erin Galeno (Chief Financial and Administrative Officer) for the Port of Tacoma presented the 2024 Budget and thanked staff who worked on it. The presentation included a follow-up of the study session, and addressed questions posed at the previous meeting. Questions and comments from the Commissioners were made throughout the presentation.

- Commissioner Keller stated that proper public notice was published in the Tacoma News Tribune, Tacoma Daily Index, and Eatonville Dispatch according to the requirements of RCW 53.35.020. The Public Notice identified the date and time of the public hearing and informed members of the public of the ability to submit written comment via email to comment@portoftacoma.com and that written comments received by 9:00 a.m. Pacific Time, Monday, November 20, 2023 would be distributed to commissioners.
- Notice was and is also provided that the Port of Tacoma (Homeport) budget impacts the Northwest Seaport Alliance (NWSA) budget, as the NWSA acts as the manager of the marine interests of the Homeport.
