A. UPDATE

On May 18, 2021, the Tacoma City Council passed Ordinance No. 28759, approving an extension of the Tideflats interim regulations for up to six months, and referring the proposed permanent regulations to the council's Infrastructure Planning and Sustainability (IPS) Committee for review and recommendation back to the full Council no later than August 31, 2021.

B. BACKGROUND

Staff prepared the attached *simple version* of Port suggestions for the city's industrial related code amendments. This is not an exhaustive list of edits the Port would desire but does address the four main areas and themes of our comments related to the Interim Regulations over the past three plus years. This list was prepared in response to a request by the IPS Committee. The committee is in possession of the full, detailed list of proposed amendments the Port previously provided, but wanted a simplified summary of the Port's concerns.

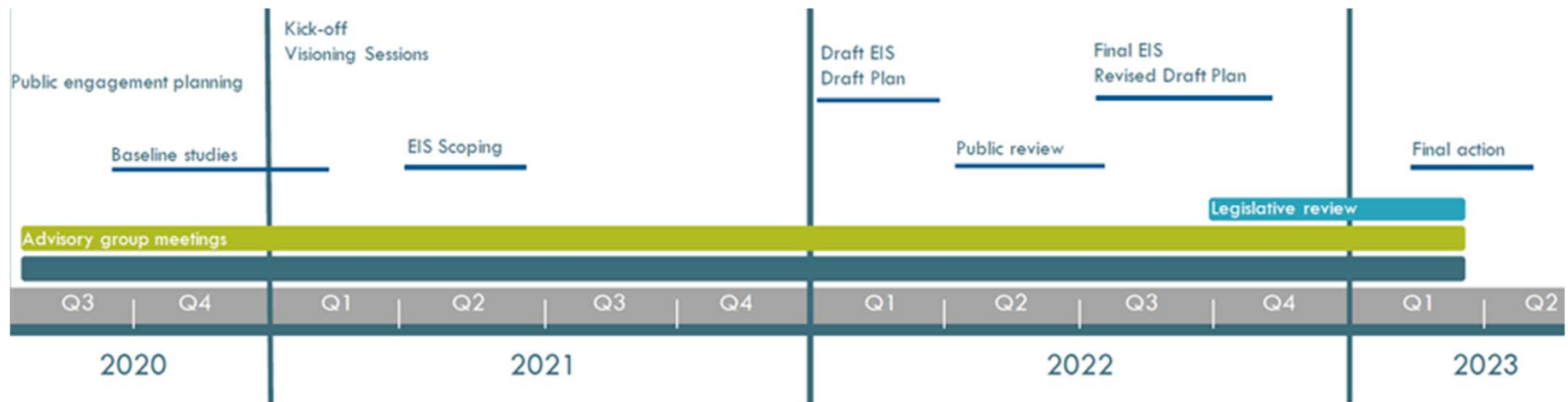
