

REGULAR MEETING

February 1, 2024 - 12:00 PM Public Session Start Fabulich Center, Room #104: 3600 Port of Tacoma Road, Fife

The Port of Tacoma Commission met for a regular meeting on **February 1, 2024** at the Fabulich Center, 3600 Port of Tacoma Road, Fife, WA. Commissioners Kristin Ang, Deanna Keller, Dick Marzano, John McCarthy, and Don Meyer were present. A quorum was met.

CALL TO ORDER | EXECUTIVE SESSION:

Commissioner Kristin Ang, Port of Tacoma Commission President, called the meeting to order at 10:00 a.m. and announced that the Commission would recess into a closed **Special Order of Business** until 10:30 a.m. to discuss a labor collective bargaining agreement. 1. RETURN TO ORDER & FLAG SALUTE:

Commissioner Ang also acknowledged that we are situated on the traditional homelands of the Puyallup Tribe and committed to uplifting the voices, experiences, and histories of the Indigenous people of this land.

- Reminded the group that the meeting today is an extra, regular meeting.
- We will be providing an update on our strategic planning goals and accomplishments today.
- Proclamation 2021-01-PT, which will be presented today, recognizes February as Black History month.
 There is a segment in the Port's Working Waterfront video series, which highlights the history of black workers at the Tacoma waterfront. He encouraged everyone to check out the five-minute video.

6. **COMMISSION ACTIONS:**

A. TWAAFA Project Authorization Increase and Approval to File Complaint Against Burlington Environmental LLC (Master ID #101082.01)

Heather Burgess (Legal Counsel) and Scott Hooton (Project Manager II—Environmental & Planning Services) with the Port of Tacoma presented. This item concerns properties known as the Taylor Way and Alexander Avenue Fill sites (aka TWAAFA). The Port has been working to manage legacy contamination at the sites to return it to public use. Previously, the Commission approved costs associated with remediation efforts and to contract legal services with NW Resource Law for recovery costs from Burlington Environmental. Efforts to resolve this outside of litigation have not been successful. Actions requested include additional funds for contracted legal services and to authorize NW Resource Law group to file a complaint in U.S. District Court.

MOTION: To approve the following:

- Additional project authorization in the amount of \$600,000 for a total authorized amount of \$2,267,000 for the Taylor Way and Alexander Avenue Fill Area (TWAAFA), Master Identification No. 101082.01, for contract legal services from NW Resource Law Group, PLLC for cost recovery litigation under the Model Toxics Control Act, RCW 70A.305 against potentially liable parties.
- Commission authorization pursuant to Master Policy Resolution Section VI for NW Resource Law Group, PLLC to file a complaint in U.S. District Court for the Western District of Washington against Burlington Environmental, LLC, seeking recovery of past and future remedial action costs incurred by the Port under the Model Toxics Control Act, RCW 70A.305 at Port Parcel 111.

- Commissioner McCarthy The Washington State Freight Mobility Strategic Investment Board will hold their
 quarterly meeting in Dupont on March 15th. He expressed interest with them in touring sites of our system of
 transportation and projects. This board is comprised of individuals in the industry and makes
 recommendations of projects to the State for funding as well.

ILWU 23 is holding an event on Feb 18th at the Foss Waterway Seaport celebrating the many accomplishments and history of Black longshore workers.
