

REGULAR MEETING

September 19, 2023 - 12:00 PM Public Session Start Fabulich Center, Room #104: 3600 Port of Tacoma Road, Fife

The Port of Tacoma Commission met for a regular meeting on **September 19, 2023** at the Fabulich Center, 3600 Port of Tacoma Road, Fife, WA. Commissioners Kristin Ang, Deanna Keller, Dick Marzano, John McCarthy and Don Meyer were present. A quorum was met.

CALL TO ORDER | EXECUTIVE SESSION:

Commissioner Deanna Keller, Port of Tacoma Commission President, called the meeting to order at 10:00 a.m. and announced that the Commission would recess into a closed Special Order of Business until 10:30 a.m. to discuss a labor collective bargaining agreement. The Commission would then recess into an Executive Session until 12:15 p.m. to discuss:

At **12:00 p.m.,** Commissioner Keller extended the Executive Session for 15 minutes and announced they would return for the public session at **12:15 p.m.**

1. RETURN TO ORDER:

Commissioner Keller returned the meeting to order at **12:15 p.m.**, followed by the Pledge of Allegiance. Commissioner Keller also acknowledged that we are situated on the traditional homelands of the Puyallup Tribe and commit to uplifting the voices, experiences, and histories of the Indigenous people of this land.

3. EXECUTIVE DIRECTOR'S REPORT – Eric Johnson

- The Port recently hired a new Security Director. Collin Millan was welcomed to the team.
- A Memorial Service for Ralph Klose (former Port Attorney) was held at the Port last week.

7. SPECIAL ORDER OF BUSINESS:

A. Recognition of Retiree – Louis Cooper

Louis offered some closing words of his time at the Port and acknowledged the folks he's worked with over the years. Each Commissioner wished him well in his retirement and thanked him for his work.

9. COMMITTEE REPORTS:

A. DEI Workgroup Update - Commissioners Ang and Marzano reported that the committee is working on the DEI plan and hope to have a draft completed by the end of the year. The work will extend far beyond

this year and continue with more employee involvement opportunities after the first of the year. Committee members were thanked for their work.

B. Workforce Development – Commissioners Keller and Ang provided an update on the committee's work. The Request for Proposals (RFP) for organizations interested in partnering with us in these efforts was recently edited to increase the likelihood of bidders. The contract is open to everyone to apply.

10. ISSUE BRIEFINGS:

A. World Trade Center Briefing - Annual Update

Mike Fowler (Executive Director & Senior Trade Consultant) with the World Trade Center Tacoma presented an annual update to the Commission. Training and events, as well as finances from the year were reviewed. The World Trade Center Globe Awards will be held on Thursday, September 28th at the Port of Tacoma Administration Building. The Port was thanked and recognized for their support.

B. Budget Priorities and Capital Investment Plan (CIP)

Erin Galeno (Chief Financial & Administrative Officer) with the Port of Tacoma presented an overview of the 2024 budget priorities. The proposed budget will be addressed further at the first meeting in November.

ANNOUNCEMENTS / COMMISSIONER COMMENTS:

- Commissioner Marzano Commented on the memorial service for Ralph Klose, congratulated Louis Cooper on his retirement and recognized Sarah Weeks for her work at the Port, as she will be leaving for work with another company. He thanked all Port employees for their work.
- 2. Commissioner Meyer Stated that he hopes the Port can reach a resolution soon on the contract negotiations that were addressed in Public Comment in today's meeting by members of ILWU Local 22.
- 3. Commissioner Ang Thanked Louis Cooper for his work at the Port, Sarah Weeks for her impactful environmental work and congratulated Christine Wolf on her retirement from the Northwest Seaport Alliance. She mentioned that the Commission takes public comment to heart. She suggested that now is the time to advocate for roads because of the transportation study on the Earley Business Center is complete.
- **4. Commissioner Keller** Recognized the folks that are retiring but is happy for them. Commissioner Keller would like to see exit interviews implemented to help address areas of improvement. She appreciates the work of the Port staff.
- 5. Commissioner McCarthy No comments were given at the meeting.
