SUBJECT:	Maritime Center Project Authorization Increase (Master ID # 101549.01) & ILA Amendment

A. ACTION REQUESTED

1. Request project authorization in the amount \$2,970,000 for a total authorized amount of \$4,770,000, for work associated with the Port of Tacoma Maritime Skills Center and Port Maritime Center, Master Identification No. 101549.01.

2. Request authorization for the Executive Director to enter into an amendment to the Second Interlocal Agreement (ILA) between the Tacoma Public School District (District) and the Port of Tacoma (Port) to outline the payment reimbursement process for the Initial Design Build Contract and establish a not-to-exceed amount for Port reimbursement of Parametrix services.

Strategic Plan Initiatives: EV-4, EL-1, OS-4, CC-1, CC-2

B. SYNOPSIS

The Port has partnered with Tacoma Public Schools to develop a Maritime Skills Center and Port Maritime Center Campus on Parcels 92 and 94. The Maritime Skills Center will support future employment needs of the maritime and logistics industry and the Maritime Center will support the Port's business operational needs with a new administration and commission space. The project will be delivered using the Progressive Design Build delivery method. This dual-action request authorizes and funds the project through schematic design (30% design) including programming, community engagement as well as master planning.

C. BACKGROUND

Since 2021, the Port has led several strategic initiatives to support developing a Maritime Skills Center in partnership with Tacoma Public Schools and a new Port Maritime Center. In March of 2023 the Port and Tacoma Public Schools executed an Interlocal Agreement to build a Maritime Skills Center on Port property. A second interlocal agreement was executed in August of 2023 to govern the planning and development of the project from execution of the Initial Design Build Team Contract through completion of initial design development, schematic design, and cost estimating. The Second ILA established that Parametrix, the District's project management firm, would be fully funded by the District up until the Initial Design Build Contract is executed. Following contract execution, Parametrix fees were to be split between the District and the Port based on services rendered up to the not to exceed maximum which is provided within this proposed Amendment to the Second ILA. The proposed Amendment to the Second ILA will go before the District Board of Directors for approval on October 12, 2023.

Concurrently, the Port and District were granted permission by the State's Project Review Committee, to deliver the project using Progressive Design Build. A selection committee comprised of District and Port staff selected a design builder through a rigorous selection process. Commission previously authorized funds in April of 2023 primarily to complete two phases of cultural and environmental investigations, the result of which have been shared with Commission and the Puyallup Tribe of Indians. This request allows the design build team to begin master planning, programming, community engagement, site selection and up to 30% design.

E. FINANCIAL SUMMARY

Estimated Cost of Project

The total project cost including all stages is estimated at \$38,000,000.

Estimated Cost for This Request

The total estimated cost of the initial 30% design phase for this project is \$2,970,000. Additional Commission authorization will be requested before the next phase of design.

Estimated Sales Tax

The total estimated sales tax to be paid by the Port and Tacoma Public Schools to local and state governments for this phase of the project is \$373,000.

Cost Details

Source of Funds

The current Capital Investment Plan (CIP) allocates \$38,025,000 for this project. The project has also been awarded the following outside funding:

• Toxic Cleanup Integrated Planning Grant, Department of Ecology, in the amount of \$300,000.

Financial Impact

Project costs will be capitalized and depreciated with estimated useful lives ranging from 10-50 years. Grant income will be recorded as non-operating revenue at the time reimbursement is requested.

F. ECONOMIC INVESTMENT/JOB CREATION

The Maritime Skills Center will employ 25 full-time staff and serve approximately 300 students on site. The Maritime Skills Center will serve as the hub of a program expected to enroll 600 students through Pierce County. The students will receive industry recognized credentials preparing them for employment in many industries in the tide flats. The Port Maritime Center is expected to house 150 employees from the Port of Tacoma and the Northwest Seaport Alliance. The local construction industry will benefit from the construction of the Port Maritime and TPS (Tacoma Public Schools) Skill center.

G. ALTERNATIVES CONSIDERED AND THEIR IMPLICATIONS

Alternative 1) Proceed with the Progressive Design Build Delivery Method – This method allows for owners to achieve cost certainty at 60% design. Construction activities can also begin earlier, shortening the life of the project. A shorter project lifespan helps mitigate inflation as well as supply chain pressures. Tacoma Public Schools' partnership with the Port is dependent on using this delivery method. TPS track record with this delivery method is excellent.

Alternative 2) Delay or defer the Port's portion of the Maritime Center Project and continue to support the District's Maritime Skills Center project.

Alternative 1 is the recommended course.

H. ENVIRONMENTAL IMPACTS/REVIEW

<u>Permitting</u>: Project will require city, state, and federal permits and close coordination with the Puyallup Tribe.

<u>Remediation</u>: Preliminary Site Assessment results indicate intermittent soil and groundwater contamination on Parcel 94. Once the site assessment report is available, Parcel 94 will be added to Ecology's list of Contaminated Sites. This project may require development of a cleanup action plan during the 30% design, depending on building locations relative to the presence of contamination.

<u>Stormwater</u>: Stormwater treatment will be designed into the site improvements.

<u>Air Quality and Sustainability</u>: Greenhouse gas emissions from the project – design through construction and long-term operations – to ensure alignment with the Port's goal of achieving net-zero Scope 1 and 2 GHG emissions by 2040, will be evaluated. Evaluation results will be used to guide design, construction, and operation of the building, including choices related to building materials, lighting and HVAC systems, and other features. In addition, compliance with the state Clean Buildings Law will be assessed, ensured, and documented.
